BUSINESS:

Acknowledge representative for Sunview Homes – discussion on water on Ranchette Rd: Darryl Burkett was present to discuss easements on the existing 4" line. Field Superintendent Pearce had informed him that we currently do not have easements for this line. He wanted to confirm that there would be water availability before they started building. Mr. Burkett stated that they will get any easements we need signed. Manager Clinton informed him that she will be working up the easements. Field Superintendent Pearce informed the Board that Sunview Homes wants to install a 2" master meter to start this new subdivision of 15 houses, which is located on South Ranchette Rd. Engineer Henderson recommends that the District not allow this unless we intend on doing the upgrade (See Attach #5).

Manager Clinton informed that she thought we had an easement for that line and that she would do more research and she will call the attorney in order to find out what our options are.
